

Watergate continues to fascinate us 50 years after the events that brought down a president! In connection with the Watergate break-in, which launched 2-1/2 years of investigation of former President Richard Nixon, Marshall H. Tanick, of the Twin Cities law firm of Meyer Njus Tanick, will discuss the many unknown and unique connections between Minnesota and Watergate. The presentation will focus on the role that Minnesotans played in key aspects of the break-in and the ensuing scandal, including several from the Twin Cities suburbs. "In many ways, Minnesota, especially the western suburbs, was ground zero of Watergate," shares Mr. Tanick. Do not miss this fascinating presentation and lively discussion that will follow!
