Marshall Tanick

Marshall Tanick, a constitutional lawyer and historian, returns with another timely and vital discussion on the Supreme Court as it finishes its most conservative term in nearly a century.

After last year's tumultuous rulings, this presentation will look at seven important and interesting cases currently before the U. S. Supreme court and their implications for Minnesota. They are highlighted by lawsuits concerning rental arrangements at the Mall of America, a copyright battle between two high-profile estates of Prince and Andy Warhol, affirmative action for racial diversity in college admissions, gerrymandering of Congressional districts, and the procedures for the 2024 Presidential election, among other matters.

On November 30th, Professor David Schultz gave a presentation on the 2022 Election to BOND members and guests. He is a Hamline University distinguished professor of political science, legal studies, environmental studies, as well as Professor of Law at the University of St. Thomas and the University of Minnesota. As an author of more than 45 books and 200 articles on various aspects of American politics and law, he clearly examined the factors that impacted the mid-term November 8, 2022 elections. Both during his talk and after a lengthly Q and A, we all came to understand what November 8 events meant locally, nationally and internationally.

BOND is fortunate to have Professor Schultz on our program agenda as one of the outstanding educators and speakers in the Upper Midwest.

# GETTING TO KNOW OUR MEMBERS Meet Jean Efron

I was born in north Minneapolis - a far different place then than now! I attended Minneapolis Vocational High School and Technical Institute - taking stenography. For many years I worked at this profession (I still write notes to myself in shorthand).

My first husband and I had 3 sons and I was a stay-at-home mom until the 3rd one went to school. After a few more years as a stenographer, I was offered the chance to go back to school to become a building inspector for the City of New Hope. It took more than two years of night classes (while working as the dept. clerk in the daytime) to be qualified to take the state certification tests to become a Building Official. I then worked over 20 years as General Inspector for the City of New Hope.

When I retired, I looked for volunteer things to do. By then I had lost my first husband and found myself at a new place in life. My first choice was to go

through JFCS where I took on the role as a "Lunch Buddy" for kids at Aquila Elementary in St.Louis Park. I loved it and I found my "calling" was working with kids in need. After several years at Aquila I gave that up when I learned of the Guardian ad litem program for Hennepin County. During these many years I had remarried and after 21 years together he also passed away.

One Shabbat at Adath, a congregant spoke of his "job" as a volunteer Guardian ad litem for the Juvenile Justice System. He inspired me to apply and I was accepted to train for the position, which is to advocate for children in the system, either through no fault of their own; i.e., their parent(s) not taking care of them or sometimes the youngster already participating in criminal activities. I am now in my 10th year and currently have only 2 cases. With some children there is much to do, taking lots of time - visiting the child at least once a month, getting updates on school through teachers, counselors, therapists, social workers, foster moms and then attending the routine hearings where the judge on the case reviews information. We are expected to be neutral, not necessarily agreeing with the opinions of the professionals. Our job is for the child's best interest and where it lies. The object is reunification whenever possible. It is very sad to terminate a parent's custody, sad for all, but mostly the child.

I will retire from this volunteer job when these last two cases are dismissed. It has been troubling, humbling, distressing and exhausting BUT also gratifying, and I know it has made me a better person. I am told this volunteer program may be eliminated and the new cases handled by paid Guardians.

I will find other things to do - I already go to an elementary school 2 mornings a week to assist 1st grade teachers with students struggling how to read. I will also have more time to attend BOND functions and events! I am happy to be a BOND member, and very proud of what we do!
